Cheers to you and to all the staff in your Division!

This is a follow-through letter of the Contract Management Division (CMD), Procurement Management Service, DepEd Central Office requesting assistance in facilitating the submission of accomplished Delivery Information Forms for Grades 1 to 6 SME Kits, (a 2016 delivery monitoring) from your respective schools in your division.

Please be informed that since our follow up letter in July 2017, we now have approximately 2,000 submissions received as of August 18 which is a significant 5.18% increase in the total number of submissions nationwide. However, out of 38, 603 SME Kit recipient public elementary schools nationwide of 2016, only 5, 845 (15.14%) schools have submissions leaving 32,758 (84.86%) schools still without submissions or no response at all.

In this reason, the CMD Office would like to specifically ask your supply officers, property custodians or designated personnel, to closely coordinate with each of all your division schools using the attached checklist. For schools that cannot submit, kindly specify the reason. Please send us the checklist after completion.

The schools may still submit the accomplished forms through any of the following methods:

- 2. by telefax at (02) 635-3762;
- 3. by printed submission thru the Records Division or direct to the CMD Office located at 5th Floor, Mabini Building, DepEd Central Office, Pasig City.

Submission deadlines:

- 1. September 15, 2017 for the accomplished DIF by Schools
- 2. September 20, 2017 for the accomplished checklist by Supply Officers/Custodians

Rest assured that all submissions will be properly acknowledged and recorded. Non-submissions are noted as well for proper action and subject for site visitation.
