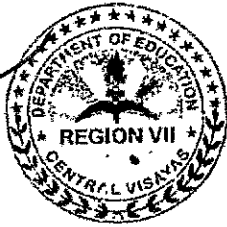

REGIONAL SCREENING OF DOCUMENTS / CREDENTIALS AND INTERVIEW OF COACHES, ATHLETES AND CHAPERONS FOR CVIRAA MEET 2018

1. The 2018 Central Visayas Regional Athletic Association (CVIRAA) Meet will be held in the Province of Bohol this February 2017 to be hosted by DepED Divisions of Bohol and Tagbilaran City, co-hosted by the Local Government Unit (LGU) of the Province of Bohol and Tagbilaran City.
2. One of the CVIRAA Meet's major preparations and requirements is the screening and interview of athletes, coaches and chaperons for accreditation and qualification to compete in their specific events.
3. In this connection, RSAC members coming from the nineteen (19) Schools Divisions comprising three (3) core members of DSAC shall officially travel to and proceed with the conduct of screening the credentials of and interview Athletes, Coaches, Assistant Coaches and Chaperons of the different participating Division Delegation as scheduled. The RSAC / DSAC ICT member shall be in charge to screen the digitalization / digitization of the scanned documents, its systematic arrangement and the reproduction of the picture gallery portfolio as required by the National Screening and Accreditation Committee (NSAC).
4. The Division RSAC members and their DSAC members shall take the lead in the preparation of their delegation credentials, facilitate the systematic flow and shall not participate in the screening and interview of their own delegation during the schedule of their respective divisions. Division MAPEH Supervisor and Sports Coordinator shall be held responsible for the attendance of their participating event athletes, coaches/asst.coaches and chaperons during the scheduled visit. Attached herewith are:
 - a) the schedule of the said activity at the Schools Divisions; and
 - b) the RSAC Team composition with event assignment and assigned Schools Division to visit.
5. Travel and incidental expenses incurred by the RSAC Members and likewise with the travel expenses of the Division Athletic Delegation to the venue shall be charged to division / school local / MOOE or any available funds subject to accounting and auditing rules and regulations. Travel Order / Authority must be duly approved and signed by the Schools Division Superintendent.
