Subject: VALIDATION OF E-CLASSROOM COUNTERPART REQUIREMENTS FOR DCP BATCHES 35, 36, 40, 41, 42, 43 and 44 (COMPUTER PACKAGES FOR PUBLIC ELEMENTARY AND SECONDARY SCHOOLS NATIONWIDE)

In connection with DepEd Computerization Program (DCP), the Information and Communication Technology Service (ICTS) will conduct validation activities to verify the readiness of recipient schools to accept DCP packages this year.

The initial validation will be based on the distribution of the DCP batches 35, 36, 40, 41, 42, 43 and 44 to the recipient schools. The Central Office thru ICTS will be sending validators to collaborate with Regional and Division IT Officers. All recipient schools tagged as not-ready of non-compliant will be given time to prepare the requirements, or if budget permits, be given assistance in order to comply. Data from this process will contribute to the establishment of DepEd Baseline data for ICT currently being documented by DepEd.

Central Office Personnel, site assignments, and schedules will be communicated once finalized. Attached for reference is list of school recipients for said DCP batches.
