1. The field is hereby informed that there are three secondary schools from the Division of Cebu Province selected by the Central office to take part in the first ever Programme for International Student Assessment ( PISA) this coming March 12-14, 2018. This is an international assessment for students aged 15 years old in areas of Mathematics, Science, English and Global Competence.

3. Rigid preparation has to be done since there is need to adhere to PISA standards in the administration of the said assessment. Hence, this one day conference is scheduled on **March 5, 2018 from 8:00 o'clock to 5:00 o'clock at DepEd Cebu Province Conference Hall.**

Participants to this conference-workshop are **Public Schools District Supervisors of Dalaguete 1, Argao 1 and Dumanjug 1, School Heads of Dalaguete NHS, Argao NHS, and Dumanjug NHS, all Division ICT Development Team, and the Division Representatives** during the PISA Seminar Workshop in Laguna.

5. Participants are required to bring laptops and USB (16 GB) to be used during the conference –workshop and to report to the venue on time.

Travelling expenses of the participants shall be charged against **local school MOOE** funds, while meals and other expenses of participants relative to the conduct of the said activity shall be charged against **Division Funds**, subject to their availability and the usual accounting and auditing rules and regulations.
