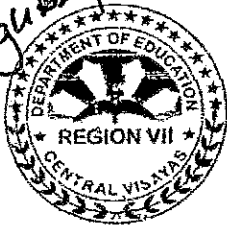

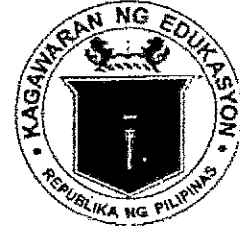

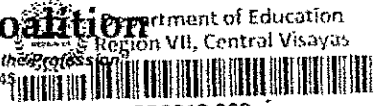

The Teachers' Dignity Coalition (TDC) will be holding the **National Seminar and Consultation-Workshop on Policies Related to Teachers' Rights and Duties** on March 16-18, 2018 at the Romulo Hall of Baguio Teachers' Camp. With the theme **"Empowered Schools, Better Education."** the seminar aims to educate our teachers and school administrators on the pertinent education policies and deepen the knowledge of teachers on the promotion of people's right to education and the wider advocacy for education reforms.
