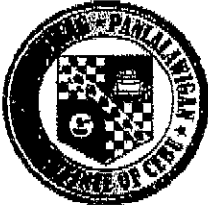

**WHEREAS**, it has been observed that gangs and fraternities are infiltrating schools including elementary and high school levels;

**WHEREAS**, that in their early years, students are expected to focus on their education such that they may become productive members in society in the future;

**WHEREAS**, it has been reported that some students are involved in unlawful activities whilst affiliated with a gang or fraternity;

**WHEREAS**, premises considered, that the Department of Education - Region VII (DepEd VII) is urged strongly to provide necessary measures to deter the students' superfluous affiliation and behavior which will be detrimental to their development and well-being;

WHEREAS, Section 16 of the Local Government Code of the Philippines states that every local government unit shall "... promote health and safety, improve public morals, maintain peace and order, and preserve the comfort and convenience of their inhabitants";

NOW, THEREFORE, on motion of Majority Floor Leader, Hon. JUDE THADDEUS DURANO SYBICO, duly seconded by Assistant Majority Floor Leader, Hon. CHRISTOPHER R. BARICUATRO, for the approval of the resolution authored by Member, Hon. VICTORIA COROMINAS-TORIBIO, co-sponsored by Member, Hon. MIGUEL ANTONIO A. MAGPALE and co-authored by Member, Hon. ALEX S. BINGHAY, be it
