ADDENDUM TO DIVISION MEMORANDUM NO. 253, S. 2018 RE RPMS END OF SY 2017-2018 EVALUATION OF TEACHING AND NON-TEACHING PERSONNEL

- 1. In cognizance with the on-going RPMS End of SY 2017-2018 Evaluation of Teaching and Non-Teaching personnel, pursuant to Division Memorandum No. 253, s. 2018, this Office recognizes the joint effort between and among the Division Validating Teams (DVTs) and the PSDSs pertaining to the agreed schedule and final venues of the said evaluation. Please refer to Enclosure No. 1: Matrix of RPMS Evaluation/Validation, SY: 2017-2018.
- 2. The validating teams shall adhere to the agreed schedule and venues to avoid delay in the submission of the validated OPCR/IPCR to this Office, *attention:* Dr. Leah B. Apao, OIC-Office of the Assistant Schools Division Superintendent, Cluster C on or before May 12, 2018.
- 3. Attention is also directed to *item no. 43* of DepED Order No. 43, s. 2015 on *Plus Factor*, specifying the following provisions:
 - 43. Plus Factor. The plus factor shall be considered as another KRA. There are value adding accomplishments, which are not covered within the regular duties and responsibilities. The weight on the plus factor shall not exceed on the weight of the highest mandated KRA.
- 4. To ensure the unified rating scheme, it is hereby instructed that raters and rates shall have adhered to the following scale:

Performance Indicators	Rating
100% accomplishment of targets	5
85% to 99% accomplishment of targets	4
75% to 84% accomplishment of targets	3
65% to 74% accomplishment of targets	2
64% & below accomplishment of targets	1

- 5. Public Schools District Supervisors shall gather all the school heads during the validation on the specified dates and present MOVs and other evidences/documents.
- 6. The accomplished performance monitoring and coaching form, Part II, III, and IV of RPMS process of all the non-teaching and teaching personnel shall be attached to the OPCR/IPCR, school year 2017-2018, which shall be submitted to this Office on the date specified above.
- 7. For your proper guidance and strict compliance.
