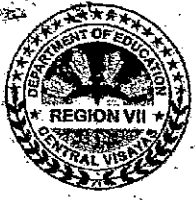

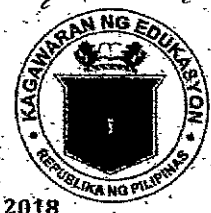

ESTABLISHMENT OF THE 2018 DEPED ELECTION TASK FORCE OPERATION AND MONITORING CENTER IN THE CENTRAL, REGIONAL AND SCHOOLS DIVISION OFFICES IN CONNECTION WITH THE MAY 14, 2018 BARANGAY AND SANGGUNIANG KABATAAN ELECTIONS

All Concerned

1. Pursuant to Article IX-C, Section 2 (4) of the 1987 Philippine Constitution, the Commission on Elections (COMELEC) has the power to deputize law enforcement agencies and instrumentalities of the government for the exclusive purpose of ensuring free, orderly, honest, peaceful and credible elections.
2. The Department of Education (DepED) is one of the national agencies deputized and granted authority by the COMELEC to ensure compliance with and enforcement of all orders and instructions relative to the election duties to ensure free, orderly, honest, peaceful and credible elections, through the appointment of public school teachers to serve as chairperson and members of the Electoral Board.
3. 2018 DepED Election Task Force (ETF) Operation and Monitoring Center for the May 14, 2018 Barangay and Sangguniang Kabataan (SK) Elections shall be established at the Bulwagan ng Karunungan, DepED Central Office, Meralco Ave., Pasig City, which starts at 2:00 p.m. of May 13, 2018 and ends on 12:00 noon of May 15, 2018.
4. The Regional and Schools Division Offices are authorized to create their respective ETF Operations and Monitoring Centers on the same dates and schedules mentioned above.
5. The ETF is created for the following purposes :
 - a) Ensure that teachers and other DepED personnel who will render election service shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties during the May 14, 2018 Barangay and SK Elections;
 - b) Serve as DepEd institutional link to volunteer organizations, individuals, as well as partner agencies involved in the conduct of the May 14, 2018 Barangay and SK Elections.
6. The Schools Division Superintendents are hereby advised to submit the names of the members of the ETF to the Office of the Assistant Regional Director on or before May 10, 2018, with the enclosed format.
7. The Division Election Task Force is required to coordinate with the DepED Regional Office Election Task Force and submit a report of all the incidents/complaints regarding the conduct of the election.
8. Attached is the DepED Memorandum No. 081, s. 2018 dated May 3, 2018, for information and guidance.
9. Immediate dissemination of this Memorandum is desired.



Pursuant to Article IX-C, Section 2 (4) of the 1987 Philippine Constitution, the Commission on Elections (COMELEC) has the power to deputize law enforcement agencies and instrumentalities of the government for the exclusive purpose of ensuring free, orderly, honest, peaceful and credible elections.
2. The Department of Education (DepEd) is one of the national agencies deputized by COMELEC to ensure free, orderly, honest, peaceful and credible elections, through the appointment of public school teachers to serve as chairpersons and members of the Electoral Board.
3. By virtue of the aforementioned authority granted by COMELEC to DepEd to ensure compliance with and enforcement of all orders and instructions relative to the election duties of the latter's personnel to ensure free, orderly, honest, peaceful and credible elections, the **2018 DepEd Election Task Force (ETF) Operation and Monitoring Center for the May 14, 2018 Barangay and Sangguniang Kabataan (SK) Elections** shall be established at the *Eluwagan ng Karunungan*, DepEd Central Office, Meralco Avenue, Pasig City, which starts at 2:00 p.m. of **May 13, 2018** and ends on 12:00 noon of **May 15, 2018**.
4. The DepEd ETF shall be headed by the Undersecretary for Administration who is instructed to immediately constitute the working committees and support mechanisms of the ETF.
5. Likewise, all regional and schools division offices are authorized to create their respective ETF Operations and Monitoring Centers on the same dates and schedules mentioned above.
6. The DepEd ETF Operation and Monitoring Center will ensure that teachers and other DepEd personnel who will render election service shall be provided with adequate information, technical and legal assistance in the course of the performance of their duties during the **May 14, 2018 Barangay and SK Elections**.
7. The DepEd ETF Operation and Monitoring Center shall also serve as DepEd institutional link to volunteer organizations, individuals, as well as partner agencies involved in the conduct of the **May 14, 2018 Barangay and SK Elections**.

8. All DepEd officials and personnel, being in the civil service, are reminded not to intervene directly or indirectly in any election campaign or engage in any partisan political activity, except to vote.
