IMPORTANT ADVISORY FROM THE OFFICE OF THE GSIS CONCERNING DEPED CEBU PERSONNEL

To: PSDS/District OICs School Principals/TICs/School Heads

- 1. Everyone is hereby informed that the Office of the GSIS, Cebu Branch Office. had sent this Office a letter dated August 30, 2018, requesting assistance in the dissemination of their new policy relative to the due and demandable loan accounts of DepEd personnel.
- 2. Starting October 1, 2018, the GSIS will charge an interest of Twelve Percent (12%) per annum on the said accounts, plus a penalty/surcharge of Six Percent (6%) per annum, both compounded monthly until the loan is fully settled.
- 3. Those with due and demandable loan accounts are advised to proceed to GSIS Cebu Branch- BCRD, 2nd floor, to settle or renew the same not later than the 30th day of September 2018.
- 4. All PSDS, or their authorized representatives, are hereby directed to claim the collection letters (segregated by district) at the Office of the Administrative Officer from **September 3-5, 2018**, and facilitate in the distribution of the same to their respective personnel in the district.
- 5. For an orderly conduct of transaction in the Office of the GSIS, a schedule is attached to this Memorandum.
- 6. This Memorandum, together with the strict reference to the schedule, will serve as official Authority to Travel.
- 7. For widest and immediate dissemination.
