4. The registration of participants will start at 7:00-8:00am for morning schedule and 12:30-1:30pm for afternoon schedule. Election will start at 8:01am for the morning schedule and 1:31pm for afternoon schedule by secret balloting. District Presidents in all districts are considered candidates for the 15 member Board of Directors except those who will volunteer or will be chosen to be part of the Election Committee (ELECOM).

- 5. The Public Schools District Supervisor in the District must issue a Certification to the Newly Elected Presidents for this school year and to be presented upon registration. Identification Card must be presented upon registration.
- 6. In order to proceed with the election, a quorum of 28 District Presidents are required. In this connection, all PSDS's are directed to inform all concerned in order to ensure maximum participation of the 55 District Presidents.
- 7. Before the election proper, the incumbent Presidents, will be given 15-20 minutes to present accomplishment reports on his/her incumbency for the School Year 2017-2018.
- 8. The Roberts' Rules of Order and the widely accepted principles/practices in Parliamentary Procedures as regards to the conduct of election used by deliberative or non-deliberative assemblies shall be given suppletory effect.
- 9. Traveling and other incidental expenses of all participants shall be charged to the School MOOE while expenses for the 2 snacks, Lunch and Dinner shall be charged to the Division MOOE, subject to its availability and the usual accounting/auditing rules and regulations.
- 10. This memorandum serves as Authority to Travel of all participants and the members of the training staff/team who will be supervising for this election.
- 11. Wide dissemination and strict compliance of this Memorandum is hereby directed.
