**RESOLUTION NO. 04 OF THE DIVISION SELECTION COMMITTEE  
REGARDING THE PRINCIPAL 1 APPLICANTS RANKING RESULTS  
(SECONDARY) FOR THE SCHOOL YEAR 2018-2019**

Whereas, a special meeting was called by ASDS DR. ESTER A. FUTALAN, the PSB/HRMPSB Chair of the Division on **October 26, 2018** to discuss issues on the appreciation of the applicants submitted documents pertaining to **“relevant experience and relevant educational qualification/degree”**;

Whereas, CSC Memorandum Circular No. 14, s. 2018, re: Revised 2017 Omnibus Rules on Appointments and Other Human Resource Action, **dated 30 August 2018**, Section 40 stipulated: “Education refers to the formal or nonformal academic, technical and vocational studies that will enable the candidate to successfully perform the duties and responsibilities as described in the Position Description Form (PDF)”;

Whereas, Section 60 of the said CSC Memorandum Circular further clearly stipulated: “Relevant experience acquired through a designation covered by an Office or Memorandum Order may be considered for meeting the experience requirement”;

Whereas, the Webster’s dictionary defined the word **“RELEVANT”** to mean **“closely connected or appropriate to the matter/subject”**; and, the phrase, **“relevant education or experience”** may still be further categorized as directly and indirectly related;

Thus, the Division Selection Committee hereby resolves the following:

1. For educational qualifications, only the degrees that are **directly aligned and vertically articulated to leadership, administration or supervision will be given points** such as M.Ed./M.A. in Educational Leadership or Administration and Supervision (thus, MA in Math/PE, Science, etc. will not be given any points);

2. For experiences of the applicants, both those (experiences) **acquired directly and indirectly** will be given points in the ranking, however, the applicants must be ranked separately based on the **indirect and the direct experiences** obtained by the applicants in order for the **Division to achieve a judicious, fair, reasonable and objective selection** of candidates, thus, three separate ranklist must be prepared based on the order of priority, such as for **HT/ASP group (Category 1), TIC group (Category 2), and for the teachers group (Category 3)**; and

3.The Committee finally agreed that the said new ranklist shall be posted in the Division's website with the attached herein Resolution for the information of all concerned.

**NOW THEREFORE**, on mass motion, the Division Selection Committee, in a special meeting called for this purpose, there being a **QUORUM**, as presided by the Chair: **DR. ESTER A. FUTALAN** unanimously agreed to pass this **RESOLUTION**.


