This is to certify that in the 17<sup>th</sup> Regular Commissioners' Meeting held on 08 August 2018, the Commission Proper confirmed the **RESOLUTION URGING NATIONAL AGENCIES TO DEFINE YOUTH AGE AS THOSE FIFTEEN (15) TO THIRTY (30) YEARS OLD PROVIDED FOR IN THE REPUBLIC ACT 8044 AND TO DISAGGREGATE DATA TO AGE REFLECTING YOUTH** to wit:

**A RESOLUTION URGING NATIONAL AGENCIES TO DEFINE YOUTH AGE AS THOSE FIFTEEN (15) TO THIRTY (30) YEARS OLD PROVIDED FOR IN THE REPUBLIC ACT 8044 AND TO DISAGGREGATE DATA TO AGE REFLECTING YOUTH**

WHEREAS, Section 13, Article II of the 1987 Philippine Constitution declares that the State recognizes the vital role of the youth in nation-building and shall promote and protect their physical, moral, spiritual, intellectual and social well-being and shall inculcate in the youth patriotism and nationalism and encourages their involvement in public and civil affairs;

WHEREAS, Republic Act 8044 or the Youth in Nation-Building Act defines "Youth" as those persons whose ages range from fifteen (15) to thirty (30) years old and mandates the National Youth Commission to provide leadership in the formulation of policies and in harnessing and developing the full potential of the youth as partners in nation-building;

WHEREAS, The National Youth Commission created the Philippine Youth Development Plan as the blueprint and guiding framework for national and local government agencies, as well as the Sangguniang Kabataan (SK), and civil society organizations in the formulation, implementation and monitoring of youth development programs and policies;

WHEREAS, the Philippine Youth Development Plan categorized youth within 15-17 years old as Child youth, 18-24 years old as Core youth, and 25-30 years old as Young Adult;

WHEREAS, the National Youth Commission as policy making-agency rely on data released by the state agencies or local data that may be collected from the different centers of participation as defined in the Philippine Youth Development Plan;

WHEREAS, without disaggregated data on age, the Commission cannot provide responsive policies that will address the needs of the Filipino youth. Without these policies and projects/programs/activities, the Filipino youth will remain undeserved and unrecognized.

NOW, BE IT RESOLVED AS IT IS HEREBY RESOLVED that the National Youth Commission earnestly urges all National Agencies to define youth age as those who are fifteen (15) to thirty (30) years old as provided for in the Republic Act 8044;
