**SUBJECT :** IDENTIFICATION OF PROSPECTIVE LGU-BIDDERS TO HOST  
THE 2021 PALARONG PAMBANSA

**DATE :** September 12, 2018

1. The 64th edition of *Palarong Pambansa*, the country's premier annual schools sports competition participated by elementary and secondary student-athletes, coaches, officiating officials, and other members of the delegation from the 17 regions nationwide, shall be staged in the Visayas region on April 2021.
2. In view of this, the Department of Education (DepEd) regional directors in Visayas are enjoined to facilitate the identification of prospective local government units (LGUs) under their respective regions that will participate in the bidding to host the aforementioned sporting event in 2021.
3. Determination of prospective LGU-bidders shall be based on their capability and readiness to host the 2021 *Palarong Pambansa*. Specifically, the LGU-bidder should observe the following criteria:
  - a. The playing venues to be used are accessible and free to the general public, well-secured, ready to be used, and are of international standard;
  - b. The billeting areas for the athletic delegations and technical officials are provided with sufficient and adequate sleeping quarters, comfort rooms, wash areas, kitchen and dining areas;
  - c. The playing venues and billeting areas capability to provide the basic services such as medical and dental, communication, adequate water supply, and uninterrupted electric power supply;



- d. The peace and order situation in the locality must be excellent and conducive to staging a national activity;
  - e. Capability and willingness of the LGU to shoulder expenses necessary for the hosting of the *Palarong Pambansa*, including construction and renovation of sports facilities, billeting areas, and other infrastructure requirements; and
  - f. The manifestation of uncompromising unity of all socio-economic-political groups, government, and non-government entities in the locality in ensuring the successful conduct of the *Palarong Pambansa*.
4. The regional office shall submit their respective list of prospective LGU-bidders to the Bureau of Learner Support Services–School Sports Division (BLSS–SSD) through email address: [blss.ssd@deped.gov.ph](mailto:blss.ssd@deped.gov.ph) on or before September 30, 2018.
  5. For guidance and reference, enclosed is the sample of the evaluation tool as basis for assessing the existing playing venues and billeting areas.
