4. School Heads with individual events are directed to look into the continuity of the training.
5. This is to inform the field further that the departure of all delegates of this Division to the 2019 CVIRAA Meet will be on February 14, 2019. All delegates are enjoined to be with the delegation on the departure day.
6. Should there be delegates who will decide not to go with the delegation on the specified date, the Management Team will not take responsibility in shouldering their travel expenses.
7. Those events which are not mentioned above as to training venues are expected to conduct the training in their own Municipality/school.
8. PSDSs and School Heads are directed to help facilitate first the provision of food to the athletes who are conducting training in their Municipality/School and keep track their schedule and attendance during the training and submit liquidation of expenses to the Division Office.
9. All concerned School Heads are directed to coordinate with Mrs. Nenita G. Jaralve on the process of liquidating the training expenses which will end on February 13, 2019.
10. Transportation expenses during the turning over of athletes to their respective teams shall be chargeable against Local School MOOE/SEF and other funds, subject to the usual accounting and auditing rules and regulations.
