

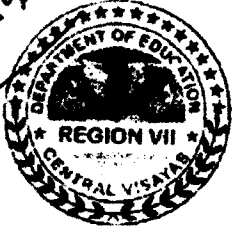

Travel, per diem and incidental expenses incurred by the RSAC Members on March 5-9 and March 11-13 shall be charged to division / school local / MOOE or any available funds while lunch, A.M & P.M. snacks which will be provided by Applied Nutrition Center (ANC) / DepEd Ecotech Center shall be charged to Regional MOOE / Palaro funds. **Transportation and meals of athletes, coaches, asst. coaches and chaperons during the interview shall be charged to their respective Divisions / Schools.** Accommodation and meals of NSAC members / interviewers on the screening dates as scheduled, including the assigned RSAC members, shall be charged to regional / division MOOE / Palaro funds.
