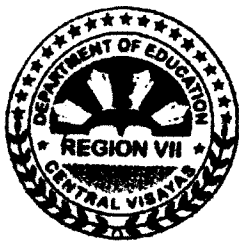

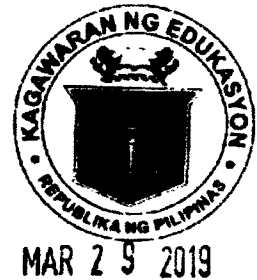

STRENGTHENING THE TRAINING PRACTICES OF CVIRAA ATHLETES FOR 2019 PALARONG PAMBANSA

To: Schools Division/City Superintendents
All Others Concerned

1. Pursuant to Regional Memorandum No. 0161, s. 2019, localized training practices of athletes (Paragraph 4) by respective event coaches was encouraged. However, these practices started right after the selection of these event athletes from the conduct of the Regional Sports Meet last February 17-22, 2019.
2. To strengthen these training practices and in readiness to the Palarong Pambansa 2019 competition, expenses incurred shall be charged to local SEF or any available funds. Likewise, picked-up athletes from other Schools Divisions who joined their team practices across to the respective dominant winning division team shall also charge travel and other incidental expenses to school / division MOOE / local SEF or any available funds, all subject to the proper accounting and auditing rules and regulations.
3. Picked-up athletes must have the necessary permits and proper travel authority from their schools, divisions and parents. Schools Divisions and Coaches concerned are encouraged to assist / adopt their picked-up athletes with their needs, meals and accommodation.
4. Schools Division Superintendents are requested to mobilize their Division Sports Officers in assisting and monitoring these practices in the respective localities and playing venues. Monitoring expenses shall be charged to Division MOOE / SEF or any available funds subject to accounting and auditing rules and regulations.
5. All CVIRAA delegation athletes, coaches, assistant coaches, chaperons and working committee members (official list is to be attached to another Memorandum issuance) are expected to report at the Cebu City Sports Complex, in coordination with the Division of Cebu City, on April 20, 2019 in preparation for departure to Davao City.
6. Immediate dissemination of this Memorandum is desired.
