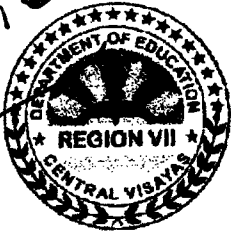

DATE : April 5, 2019

Executive Order No. 77 increased the rates of travel expenses and allowances of official local and foreign travels of government personnel.

The provisions and new rates indicated in the said EO shall take effect fifteen (15) days after its publication in the Official Gazette (March 21, 2019) which is on **April 05, 2019**¹. However, payment and reimbursements of the said travel expenses and allowances shall be paid only upon issuance of internal guidelines², which is currently being crafted by the DepEd.

In the meantime, **all offices and units are instructed to readjust the 2019 Work and Financial Plan** to reflect the new rates for local and foreign travels, under the EO No. 77 effective April 5, 2019 onwards, **within the same budget ceiling** for FY 2019.

Readjustments may be in the form of reprioritization of planned activities and/or review of the target participants per activity, etc. to maintain the same level of FY 2019 funding.
