3. Conduct himself / herself in such a manner as not to bring disgrace or dishonor for himself/herself, his/her school and the Department;
4. Submit to the Bureau of Learning Delivery (BLD), Student Inclusion Division, (SID), at the end of the training, a copy of his/her re-entry action plan and signed MOA;

5. Immediately report to his/her station and assume his/her function upon the completion of the training;
6. Organize the inclusive programs in the area where he/she was trained;
7. Shall serve his/her school/agency for at least (2) years after the training;
8. Shall refund in full to DepEd all expenses incurred on tuition fees, stipend, salaries and other benefits for failure to comply with any of the foregoing conditions, through wilful neglect, resignation from service, transfer to other government agencies, voluntary retirement or other causes within his/her control.
