8. You are entitled to have an overtime pay for your services on May 13, 2019 or a 3-day service credits/CTO, subject to the availability of funds and existing auditing rules and regulations, as well as pertinent Civil Service laws.

9. All concerned personnel are hereby directed to accomplish Daily Time Record (DTR) and prepare an Accomplishment Report. Submit the said documents to this Office on or before May 15, 2018.
10. Travelling, food (meals and snacks), and other incidental expenses to be incurred by each personnel shall be chargeable against School/Division/Local Funds, subject to the usual accounting and auditing rules and regulations.
