




Pursuant to Section 5 of DepEd Order 55, s. 2016, *Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program*, examinees who shall take the A&E Test for **Elementary Level must be at least 12 years old** and at least **16 years old for the High School Level**. In the previous A&E Test, there were Division Offices that allowed students to take the test even if they were not qualified due to the age requirement. With this, it is recommended to instruct the testing personnel especially the registration officers, to strictly comply with the requirements as stipulated in the DepEd Order.
