- 1. This Office hereby announces the conduct of the "Three-Day Capability Building on the Provision of Technical Assistance for Core Field Technical Assistance Teams on January 20-22, 2020 at Kamagong Hall, Ecotech Center, Sudlon, Lahug, Cebu City.
- 2. This capacity building program aims to equip the CFTATs with the essential knowledge, skills, and attitudes as TA providers . Specifically it enables the participants to:
 - a. share significant practices in the provision of timely, accurate, and appropriate interventions;
 - b. reflect their own techniques and strategies in facilitating the quality provision of relevant, timely, data-driven technical assistance to schools;
 - c. value strong collaboration between and among members of the CFTATs and other personnel across all levels.
- 3. Participants to this activity are the Members of the Division Core Field Technical Assistant Team and all District Supervisors. Refer to the enclosed list.
- 4. The CFTATs are hereby directed to give their participation as their top priority. 100 % attendance is expected.
- 5. Members of the Program Management Team /Training Support Staff /Resource Speakers are expected to be at the venue on **Day Zero -January 19, 2020** for the preparation of the training venue, and materials needed. Hence, these personnel shall be entitled of the **Compensatory Time-Off (CTO)** for services rendered during Saturdays, Sundays, and Holidays. Likewise, teacher participants shall be given **Service Credits** on

Day Zero in accordance to the existing Civil Service Commission or DepEd Order issuances. Expenses such as, venue rental, accommodation, meals, and snacks of the members of Program Management Team and Resource Speakers on January 19, 2020 as well as their breakfast on Day 1 - January 20, 2020, shall be charged against **Division HRD/MOOE Funds**, subject to its availability and the usual accounting and auditing rules and regulations.

- 6. Participants from Camotes and Bantayan Islands will be provided with room accommodation on Day Zero, January 19, 2020. However, they shall take charge of their dinner/supper.
- 7. The Section Head of the Medical Team through Dr. Virgilio Tantuico is directed to assign **two** (2) Division Nurses to station at the training venue on the above-mentioned dates.

- 9. Please be informed further that **FIRST MEAL** will be **MORNING SNACKS** on **Day** 1, **January 20**, 2020 and the last meal is **DINNER** on **Day 3**, **January 22**, 2020.

Travelling expenses of the participants shall be charged against **local/School MOOE**, while expenses for venue rental, accommodation, meals and snacks, training materials, tarpaulin, and other incidental expenses shall be charged against **Division MOOE Funds**, subject to its availability and the usual accounting and auditing rules and regulations.


