1. Relative to the selection and hiring of new Teacher Applicants, this Office announces the administration of the **English Proficiency Test (EPT) on February 22, 2020 (Saturday)** at 8:00 am in Minglanilla Central Elementary School, Minglanilla, Cebu.
2. All teacher applicants are requested to bring the following: pencil, preferably Mongol #2, clean sheet of paper, sharpener, and identification card (preferably PRC ID).
3. Further, they are expected to be at the testing center before 7:00 am.
4. As stipulated in DepEd Memorandum No. 106 s. 2019 dated August 30, 2019, entitled "ADMINISTRATION OF THE ENGLISH PROFICIENCY TEST (EPT) for TEACHER APPLICANTS NATIONWIDE", the result of the EPT shall be valid for TWO (2) years from the time of the test administration. Therefore, applicants who had taken the EPT last year, may not take the test this year and may retain their previous scores.
5. District Supervisors are directed to submit **SOFT COPY of the LIST OF TAKERS in EXCEL FORM using the template in Enclosure No.2**, in their respective districts to Mrs. Maria Socorro N. Relacion at socorrorelacion@gmail.com on or before **FEBRUARY 13, 2020**. Late submission will not be accepted. Those applicants who had taken the EPT last year will not anymore be included in the list. Please refer to Enclosure No.3 of this memorandum for the list of teacher applicants who had taken the EPT last year.
6. Public Schools District Supervisors, school heads for elementary and secondary are directed to inform all teachers applicants on the administration of the EPT.



8. Attendance of DepEd Personnel involved in the administration of the test will merit a one-day Compensatory Overtime Credit (COC) for Non-Teaching Personnel and one-day Service Credit for Teaching Personnel per Civil Service Service guidelines.

9. Travelling expenses of the School Heads and teachers who will serve in the administration of the EPT shall be charged against **local/School MOOE** while, travelling expenses, board and lodging of the BEA Personnel, meals (breakfast,lunch, and snacks) of all personnel involved shall be charged against **Division MOOE Funds** , subject to its availability and the usual accounting and auditing rules and regulations.
