Prior to the BEEA GRADE-12 administration, this Office will conduct a one-day **ORIENTATION** to all school heads of the both public and private schools on **March 23, 2020** at Minglanilla Central Elementary School, Minglanilla, Cebu at exactly 8:00 am. Please report to the venue on time. Distribution of the BEEA -SHS GRADE-12 test materials shall follow right after the orientation.
4. District Supervisors are directed to inform all Senior High Schools in their respective districts both public and private schools and ensure 100 % attendance of the school heads during the orientation.
5. Traveling, meals, per diem, and other incidental expenses incurred by the School Heads relative to the conduct of the said activity shall be chargeable against **local/School MOOE** subject to the usual accounting and auditing rules and regulations while traveling, meals, per diem, and other incidental expenses of the Division Personnel and the morning snacks of the School Heads shall be charged against **Division/BEA Funds** subject to the usual auditing rules and regulations.
6. This Memorandum serves as the **Authority to Travel**.
