**GUIDELINES RELATIVE TO THE CONDUCT OF THE
END-OF-SCHOOL-YEAR RITES**

To: Schools Division Superintendents
Assistant Schools Division Superintendents
All Others Concerned

1. The Department of Education (DepEd) has issued DepED Order No. 002, s. 2020, entitled "*Multi-Year Implementing Guidelines on the Conduct of the K to 12 Basic Education Program End-of-School-Year Rites (EOSY)*", relative to the procedures adopted to meet the curriculum requirements at the end of the school year and in consideration with the emerging health issue of the country.

2. As part of the implementation of DepED Order No. 002, s. 2020 and in consultation with the Schools Division Superintendents, the following shall be adopted by DepEd Region 7 :

Graduation Rites	<ul style="list-style-type: none">• All SDOs within the week of April 13-17, 2020 except City of Naga Division with no graduation following the City Executive Order No. 88, s. 2020 "<i>Declaring the Cancellation of Graduation Rites, Recognition and Moving Up Ceremonies and All other Related Activities From Pre School to Post Graduate Levels</i>".• Safety measures will be observed consistent with the DOH guidelines.• Depending on the health situation, the schools in consultation with the Parents-Teachers Association (PTA) may choose to reschedule or forego the holding of the graduation.
Administration of the National Examinations	<ul style="list-style-type: none">• As scheduled but for SDOs with suspension of classes will have to submit a report to the RO.
Final Examinations	<ul style="list-style-type: none">• Administered as soon as the suspension is lifted.

Suspension of classes	<ul style="list-style-type: none"> Learners will be given home assignments.
Reporting of teachers to school from March 23 to April 3, 2020	<ul style="list-style-type: none"> Teachers are not required to report to schools but required to finish all the academic requirements of the learners and submit the required year end reports.

2. It is also reminded to adopt the social distancing measures in schools with regard to the conduct of the fourth quarter examination and moving up and graduation rites for School Year 2019-2020.
3. Updates guidelines and advisory by the Inter-Agency Task Force on Emerging Infectious Diseases (IAFT-EID) headed by the Department of Health (DOH) shall be strictly observed and complied.
4. Immediate dissemination of this Memorandum is desired.
